Appeal Case No. 110 of 2016

Shri A. Keshorjit Singh – Appellant

-vs-

The SPIO/ Director of Medical & Health Services, Govt. of Manipur and another – Respondents

DECISION

Dated 19 September, 2016

The FAA and SPIO are represented by Smt Dhaneshwori Devi, OSD (Legal) and Shri Babulindra, Advocate respectively. The appellant is also present.

The appellant submitted that with regard to query No. 1 to 3, the information furnished by the SPIO is not authenticated. And with regard to query 4 and 5, no information has been received so far.

The Ld. Counsel of the SPIO submitted that another set of authenticated copies of information in respect of queries No. 1 to 3 will be supplied to the appellant. In respect of query No. 4, he handed over a copy of Govt. of Manipur Office Memorandum No. 5/1/2010 – FD (PIC) dt.19-11-2010 regarding payment of Non-Practicing Allowance to Medical and Vety. Doctors. However, with regard to query No. 5, the Ld. Counsel submitted that due to shortage of manpower the Department is handicapped in publishing the pro-active disclosure till date.

The appellant expressed his willingness to the request of the Ld. Counsel of the SPIO to provide another set of authenticated copies in respect of queries 1 to 3. However, the appellant submitted the publication of proactive disclosure is mandatory under the RTI Act, 2005.

After hearing from both parties and perusal of case records and also as agreed by the both parties, the SPIO is directed to provide a new set of authenticated information in respect of queries 1 to 4 within 1 (one) week from today.

The Commission also directs the Public Authority i.e. Medical Directorate to compile information on the 17 manuals and publish the same either as hard copy or uploading in the website of the Department as provided u/s 4 (1) of the RTI Act, 2005 within a period of 6 (six) months from today.

With the above direction, the appeal case is closed.
