

The Appellant also agreed with the request made by the Public authorities for closing the case. Accordingly, the present Appeal case is closed.

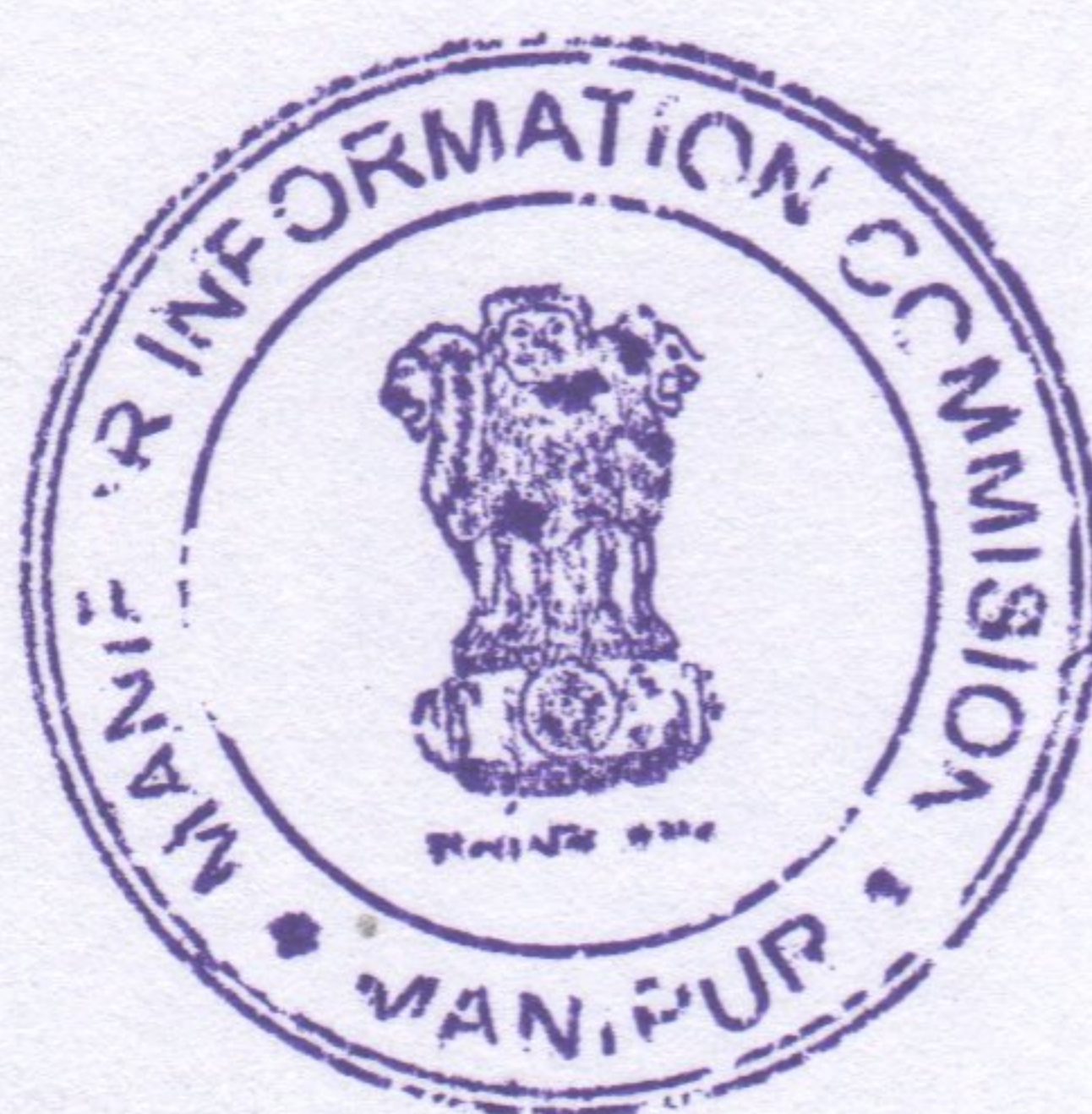
