DECISION

The SPIO/ Office of DC, Tamenglong is absent. The Appellant is present.

During the hearing the Commission received a letter dated 15.1.2025 from the DC Tamenglong, wherein the Public Authority stated that the sought information is a third party information u/s 11 of the RTI Act. He added that a letter 16.12.2024 has been dispatched to the concerned parties/ stakeholders inviting their consent for the said information, however, he added that no reply has been received from the parties concerned till date. He further added that without obtaining the consent from the parties/ stakeholders, the SPIO/ FAA could not furnish the sought information to the Appellant. He also submitted that the Public Authority has received a legal notice submitted by N. Suresh Meitei on behalf of Shri Thuankulung Gangmei, one of the stakeholders in the present RTI application praying the SDC (Branch Officer) to DC, Tamenglong to reject the RTI Application filed by the Appellant on the plea that the sought information is a personal information, disclosure of which may endanger the life and physical safety of the individual.

The Commission asked the Appellant to show any verifiable proof whether disclosure of the sought information involves public interest. The Appellant could not give any satisfactory answer. And lastly, the Appellant prayed the Commission to pass any appropriate Order.

After hearing from the Appellant and perusal of the written statements from the Public Authorities, the Commission is of the opinion that the sought information pertains to an individual information; and that disclosure of such information may amounts to interference with the individual rights and endanger the life and physical safety of the stakeholder/ party.

Accordingly, the Commission is of the opinion that further proceedings on the present Appeal case is not required.

With this observation, the present case is closed.
