The Executive Engineer, Kangpokpi Division, PWD is represented by Maharabam Felix, LDC, Kangpokpi Div., PWD. The Executive Engineer, Store Division is represented by Ksh. Pralhada Singh, UDC, (PWD), Manipur. The Executive Engineer, Imphal East Division, PWD is represented by Shri M. Ningthemjao Singh, dealing Clerk, PWD. The Executive Engineer, Building Division – II, PWD is represented by Shri A. Manitomba Singh. The Executive Engineer, Senapati Division, PWD is represented by M. Jayenta Singh, LDC, PWD.
