DECISION

Shri Naorem Pritam Singh, SPIO/ BDO, Chandel appears in person. The Appellant is present via audio conference.

During the hearing, the Appellant reiterated that the information for query No. 3, i.e., GPS photo of the place before construction and photo of the progress and photo after completion of construction for the year 2022-2023 and 2023-2024 are yet to be provided by the Public Authority. He also pressed for obtaining the hard copy of the information for the above mentioned query No. 3.

In response, the Public Authority, submitted that the RTI application dated 10.7.2024 was received on the same day and the required information dated 11.7.2024 has been provided to the Appellant through postal service on 12.7.2024, and the same was delivered to the Appellant on 29.7.2024 as per the records of the post office. He also submitted that the information sought by the Appellant are available in the web link <https://pmayg.nic.in/>. He further added that the process for accessing the information via the web link <https://pmayg.nic.in/> has already been shown to the Appellant in his Office earlier. He also submitted that as all the information has been proactively disclosed u/s 4 of the RTI Act, the need for providing hard copies of the information for the pertinent query No. 3 does not arise. However, he assured the Appellant to extend possible help in guiding the Appellant in accessing the said information.

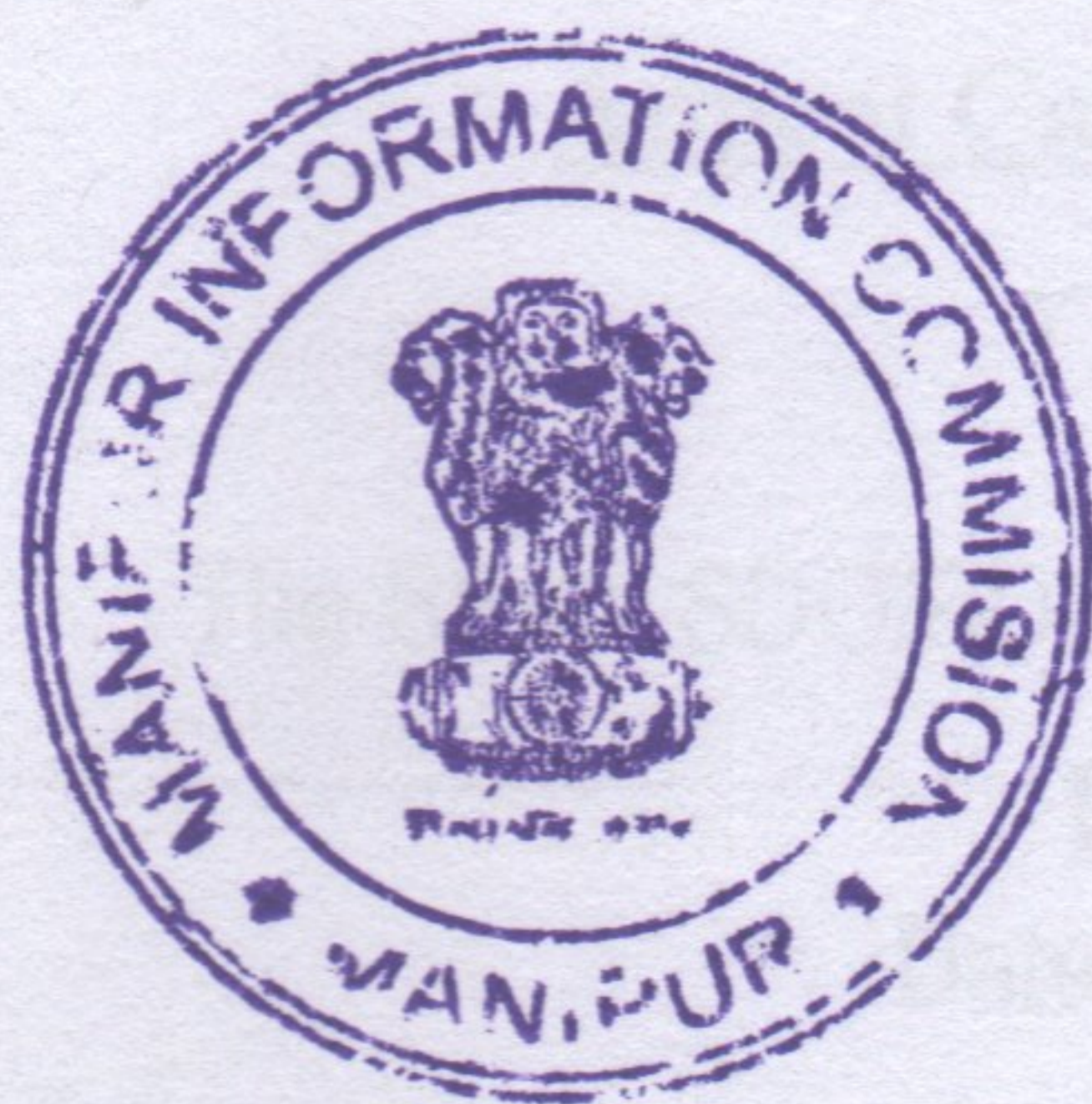
The Commission once again has checked the GPS photo of the place before construction and photo of the progress, and photo after completion of construction for the year 2022-2023 and 2023-2024 through the said web link and it has been found that all the required information is accessible/ available.

After hearing from both the parties and perusal of the case records, the Commission observes that the information sought by the present Appellant has been proactively disclosed by the Public Authority as per the provision of the RTI Act u/s 4 (Suo-motu disclosures). The Commission also observes that the Public Authority has provided the sought information to the Appellant on time, and as such, the need for further proceedings in the present case is not required.

Accordingly, the Appellant is advised to take any help from the concerned Public Authority if he faces any difficulties in accessing the said information from the said web link.

The Commission also directs the SPIO of SDO/ BDO, Chandel to extend possible help to the Appellant, if requested.

With this observation, the present Appeal case is closed.
