BRIEF FACTS OF THE CASE:

The appellant, Shri Soram Tekendrajit Singh, filed an RTI application dated 16-12-2025 before the SPIO/Deputy Secretary (Health & FW), Government of Manipur, seeking detailed information regarding infrastructure, manpower, equipment and facilities available in the District Hospitals of Kamjong, Senapati, Tamenglong and Ukhrul. Since no information was received within the stipulated period, the appellant preferred a First Appeal dated 22-01-2026. As the First Appellate Authority also failed to dispose of the appeal within the prescribed time, the appellant approached this Commission by way of Second Appeal under Section 19(3) of the RTI Act, 2005, praying for direction to furnish the information and for imposition of penalty under Section 20 of the Act.

PROCEEDINGS OF THE HEARING:

The case was heard today on 18-05-2026. The First Appellate Authority was represented by Smt. N. Dhaneswori Devi, Legal Officer, Health Department. Shri Bantee Singh Konthoujam, SPIO/Joint Secretary (Health) was present in person. The SPIO/Director of Health Services, Manipur was represented by Shri Kh. Babulindra Singh, Legal Officer. The appellant was represented by Shri S. Johnson, Advocate.

During the hearing, the representative of the SPIO/Director of Health Services, Manipur submitted that the information dated 14-05-2026 had already been furnished to the appellant through Speed Post on the same day.

However, the Ld. Counsel for the appellant submitted that the said information had not been received by the appellant as yet. A copy of the information dated 14-05-2026 was then provided to the Ld. Counsel for the appellant during the course of hearing. After perusing the said information, the Ld. Counsel for the appellant submitted that the information furnished by the respondents is found to be satisfactory and the appellant has no further grievance. He therefore prayed for closure of the appeal proceedings.

DECISION:

In view of the submission made by the Ld. Counsel for the appellant that he is satisfied with the information provided by the respondents, no further intervention of this Commission is required. The appeal is accordingly disposed of and closed.

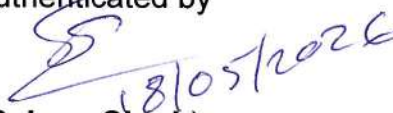
