**DECISION**

Dated: - 3.4.2025

The FAA is represented by Smt. Ningshan Pretima, Under Secretary (SLEC) and the SPIO/ Smt. Laishram Bijeta Devi, LO (MBOCWBB) is also present. The Appellant is present.

**Brief Facts of the Case:**

The Appellant filed his RTI application dated 2.1.2025 addressed to the Secretary (MBOCWBB) on 3.1.2025 and sought certain information relating to empanelled NGOs/ Training providers (TPs) under the MBOCWBB. Getting no response from the SPIO, he filed his First Appeal to the First Appellate Authority/ Principal Secy./ Commissioner/ Secretary (Labour Department), Government of Manipur on 3.2.2025 and Second Appeal to this Commission on 4.3.2025.

**Summary of the Hearing and Decision:**

The case was heard on 3.4.2025. The SPIO has submitted his written statement and stated that the information regarding query No. 1 are uploaded in the official website [www.manipurbcwb.in](http://www.manipurbcwb.in). With regard to query No. 2 (a) she submitted the following total number of TPs which are pending for disbursement with respect to their respective amounts –

With regard to query No. 2 (b), she clarified that the result for delay in the disbursement/ release of the said amount was due to shortage of balance of fund which was earmarked for Skill Development Training Programme.

Regarding query No. 3, the SPIO submitted that as the information sought by the Appellant is a third party confidential information the same is exempted u/s 8 (1) (j) read with Section 11 of the RTI Act, 2005.

On being asked to clarify the type of information he desired in query No. 3 of his RTI application, the Appellant submitted that he want to know on whether the Training Programmes was conducted effectively or not.

After thorough discussion the Appellant was advised to file another RTI application for inspection of Works/ Training, if he desires. Both the parties also agreed to close the Appeal proceedings.

Accordingly, the present Appeal case is closed.

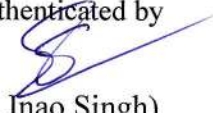
