DECISION

The SPIO/ Chief Engineer (MSRRDA/ RED), Manipur is represented by Shri Peter, Legal Officer (MSRRDA/ RED), Manipur. The Appellant is absent.

During the hearing, the representative of the Public Authority submitted that information for query No. 1 & 2 had already been provided to the Appellant. However, he added that in case of query No. 3, the Public Authority could not provide the sought information as personal bank account No. and personal bank details of the contractors are involved. He also stated that as per the Order dated **27.3.2025** the Director General, National Rural Infrastructural Development Agency (NRIDA) in para A (vii) of the circular stipulates that, "The Assessment of subsumed tax shall be submitted by the contractor duly certified by the Chartered Accountant. It is the responsibility of the contractor to furnish correct details of the subsumed taxes".

As the Appellant is absent, no comments/ written reply could be obtained from him despite the Commission's advice to the Appellant on **30.5.2025** for filling a written reply to the rejoinder of the Public Authority.

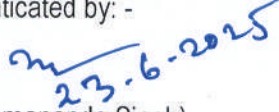
After hearing the submission of the Public Authority, the Commission is of the opinion that information on query No. 3 pertains to personal contractor bank details, personal account Nos. and IFSC code and as such, the denial of the information on query No. 3 by the Public Authority is upheld.

Hence, the present Appeal case is closed.
