DECISION

Dated: - 24.6.2025

Both the SPIO and the Appellant are present.

Brief facts of case: The Appellant filed his RTI application dated 12.3.2025 to the State Public Information Officer (SPIO)/ Registrar of Societies, Manipur and sought information regarding the status report of the R.R. No. 897 of 14.1.2025 of the Registrar of Societies, Government of Manipur. Dating no response from the SPIO, the Appellant filed his first appeal dated 21.4.2025 addressed to the Appellant Authority/ Registrar of Societies, Government of Manipur and second appeal dated 26.5.2025 to this Commission.

Summary of Hearing and Decision: the case was heard on 24.6.2025. During the hearing, the SPIO furnished the information dated 19.6.2025 to the Appellant and submitted that due to over load of works and flood in the Office compound, the concerned section had delayed in tracing out the required information and processing for providing the information to the Appellant. He apologised for the delay and requested the Commission to condole the SPIO for delay in providing information to the Appellant.

The Appellant after examination of the information submitted that he is satisfied to with the information. However, he pressed for taking action against the SPIO for delay in providing the information to the Appellant.

After hearing from both the parties and perusal of case records, the Commission takes serious view on the delay of providing information to the Appellant and directs the SPIO to strictly comply with the provisions of the RTI Act, 2005 while dealing with the RTI matters in future.

With the above observation and direction, the appeal case is closed.

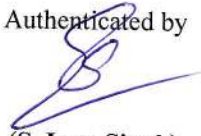
