DECISION

The present Second Appeal under Section 19(3) of the Right to Information Act, 2005 was filed by the Appellant on 02.04.2026 being aggrieved by the non-supply supply of information in respect of her RTI application dated 18.12.2025.

2. Today, the matter was listed for hearing. Both the SPIO, Manipur Building and Other Construction Workers' Welfare Board (MBOCWVB) and SPIO (SLEE) appeared before the Commission. The Appellant remained absent despite due notice.
3. The Commission perused the records and noted that the SPIO, MBOCWVB vide letter No. MBCWB/RTI-APN/11/2025 dated 21.05.2026 has furnished the query-wise information to the Appellant with clarification that the administrative expenditure is a collective figure of wages & salaries, POL, stationery and other office expenses.

4. The Commission observes that the information sought by the Appellant has now been provided by the SPIO, MBOCWWB on 21.05.2026, i.e., before the hearing of the present Second Appeal.

In view of the above and considering that the Appellant has not appeared before the Commission to press any further grievance or to point out any specific deficiency in the information supplied, the Commission is of the considered opinion that no further intervention is required.

Accordingly, the Second Appeal stands disposed of and closed.
