DECISION

The SPIO is represented by Shri M. Rabichandra Singh, Under Secretary (DP), Government of Manipur. The Appellant is also present.

Brief fact of the case: The Appellant filed his RTI application dated 21.03.2025 to the SPIO, Department of Personnel & Administrative Reforms, Government of Manipur and sought information relating to transferred and posting order along with designation in respect of Smt Nungshitombi Athokpam, Commissioner (Law), Government of Manipur for the period between 2010 to 2018. The Appellant also sought information on whether transferred and posting or utilization order of Grade-III & Grade-IV staff be issued in the name of the Governor. The SPIO had provided query wise information dated 16.4.2025 to the Appellant. However, being not satisfied with the said information, he filed the first appeal dated 24.4.2025 and to the First Appellate Authority of the Department of Personnel & Administrative Reforms, Government of Manipur and the FAA passed its decision on 14.5.2025. Thereafter, the Appellant filed the present second appeal to this Commission on 21.5.2025.

Summary of the Hearing and Decision: The case was heard on 17.6.2025 and 7.7.2025.

During the hearing, the representative of the SPIO furnished the additional information dated 7.7.2025 to the Appellant.

After examination of the said information, the Appellant submitted that he is satisfied with the information and requested the Commission to close the appeal proceedings.

Accordingly, the appeal case is closed.
