DECISION

Dated: 02-06-2026

Both the FAA and the SPIO are absent. The Appellant is present in person.

Brief Facts of the Case:

The Appellant filed an RTI Application dated 19.01.2026 before the Superintendent of Police, Kakching seeking information regarding (i) name and rank of the Officer-in-Charge of Hiyanglam Police Station posted on 18.02.2022, (ii) name and rank of the Second-in-Command (2nd OC) of the said Police Station on the said date, (iii) copy of General Diary Entry No. 10/HLM-PS/2022 dated 18.02.2022 along with annexures, and (iv) exact timestamp of the said GD entry. Since no information was received within the stipulated period, the Appellant preferred a First Appeal on 25.02.2026 before the Chief Secretary (Home), Government of Manipur. As the First Appellate Authority also failed to dispose of the First Appeal, the Appellant approached this Commission by way of the present Second Appeal under Section 19(3) of the RTI Act, 2005.

Hearing and Submissions:

Today, the matter was listed for hearing. The Appellant appeared in person. Both the State Public Information Officer (SPIO) and the First Appellate Authority remained absent despite due service of notice. During the course of hearing, the Appellant submitted that he has now received satisfactory information from the Office of the Superintendent of Police, Kakching vide letter No. A-33/SP-KCG/2018/ dated 30.04.2026, whereby the requisite details have been furnished, including the names

of the then Officer-in-Charge and 2nd OC, copy of the GD entry and the time i.e. 06:30 am. The Appellant expressed his full satisfaction with the information supplied and requested the Commission to close the present Second Appeal proceedings.

Decision:

In view of the clear statement made by the Appellant that he has received the desired information to his full satisfaction and his specific prayer for closure of the case, this Commission finds no reason to continue with the present proceedings. Hence, the present Second Appeal is disposed of and closed as satisfied.
