The SPIO is represented by Shri Warekpam Amuchou Singh, Inspector Co-operative Societies, Manipur. The Appellant is also present alongwith Shri W.Joykumar Singh, Advocate.

Brief facts of the case:

The Appellant filed his RTI application dated 14/11/2024 addressed to the State Public Information Officer, Office of the Registrar of Societies, Government of Manipur and sought certain information the relating to complaint made by the Appellant / Vice President, Imphal- Ukhrul Road Zonal Taxi Association (IURZTA) to the Registrar of Societies, Government of Manipur. Getting no response from the SPIO, the appellant filed his first appeal application dated 16/12/2024 addressed to the Appellate Authority/ Registrar of Societies, Government of Manipur. The First Appellate Authority (FAA) also failed to dispose of the first appeal within the stipulated time and accordingly he filed the present second appeal to this commission on 16/01/2025.

Summary of the Hearing and Decision:

The case was heard on 6/2/2025, 27/2/2025, 27/3/2025, 21/4/2025 and 26/5/2025.

During the course of hearing the SPIO had provided query- wise information to the Appellant except part of the information in respect of query No. 6. In this regards, both the parties also agreed to provide enclosure copies of the complaint dated 13/2/2020 (12/2/2020) which was referred in the RTI application dated 14/11/2024 to the Appellant.

The representative of the SPIO assured to provide the left out information on a convenient date of the Appellant and prayed to close the appeal proceedings.

The Ld. Counsel of the Appellant also did not object to the request of the SPIO.

After hearing from both the parties and perusal of the case record and also as agreed by both the parties, the appeal is closed.
