DECISION

Dated: - 29.7.2025

The SPIO/ Director (YAS), Manipur is represented by U. Agusta, Advocate. The Appellant is also present.

During the hearing today, the Ld. Counsel of the Public Authority submitted that the present RTI petition filed by the Appellant to the SPIO and the FAA, YAS on 16.4.2024 & 27.6.2024, now filed as Second Appeal before the Commission be disposed of as it has lapsed 90 days. He also submitted that as per Section 19 (3) (1) such Second Appeal should lie within 90 days from the date on which decision should have been made or was actually received with the State Information Commission. He also added that the Appellant has not provided suitable plea /condonation request to the Commission for the said delay.

After hearing from the parties and examination of the RTI applications, the Commission finds that the present 2nd Appeal was filed after 11 months and four days. The Appellant also fails to submit his application/ submission for condonation on the delay and fails to fulfil the Section 19 (3) (1) of the RTI Act, 2005 which stipulated that “A second appeal against the decision under sub-section (1) shall lie within ninety days from the date on which the decision should have been made or was actually received, with the Central Information Commission or the State Information Commission:

Provided that the Central Information Commission or the State Information Commission, as the case may be, may admit the appeal after the expiry of the period of ninety days if it is satisfied that the appellant was prevented by sufficient cause from filing the appeal in time”. However, in the present case no reason for delay has been shown.

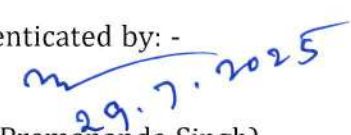
Accordingly, the present Appeal case is dismissed.
