The SPIO is represented by Ms. Joshna Thoudam, Lecturer, AIU. The Appellant is also present through Video Conference.

Brief fact of the case:- The Appellant had filed the RTI application dated 21/01/2025 to the SPIO, Asian International University, Ghari Awang Leikai and sought verification of his completion record in Master of Science (Chemistry) from Asian International University, Ghari in the year 2021-2023 under Wide Enrol/ Reg. No. 219113055760. Getting no response from the SPIO within the mandated period, the Appellant filed his first appeal dated 3/3/2025 to the FAA, Asian International University, Ghari and second appeal dated 6/5/2025 to the Commission.

Summary of the hearing :- The case was heard today. During the hearing the Appellant submitted that he already checked and gone through the official website of the University but not found his certificate for the End Term Exam June 2025 (backlog).

The representative of the SPIO submitted and clarified regarding the reason for not uploading the relevant records in the official website and informed the Appellant that the relevant records will be uploaded after due verification. She also requested the Appellant to cooperate in the verification process.

After hearing the clarification from the respondent, the Appellant submitted that he is satisfied with the said clarification and agreed to close the appeal proceeding.

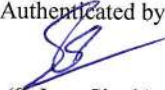
Accordingly, the appeal case is closed.
