DECISION

Shri Lanjoy Thoudam, Deputy Secretary (Land Resources), Government of Manipur and Shri Wahengbam Eden Singh, Senior Secretariat Assistant, (LR) appeared in person. Shri Prem Kumar, the Appellant is absent.

Facts of the Case:

One Shri Prem Kumar filed an RTI application to the concerned Public Authority, Land Resource (LR) Department on 17.1.2025 u/s 6 (1) of the RTI Act seeking information regarding land registration for Revenue Village 98-Bengi and 99-Charangpat Maklang under Thoubal district, Manipur.

Thereafter, he filed First Appeal petition to the FAA/ Secretary (LR), Government of Manipur u/s 19 (1) of the RTI Act.

Having no relief from the concerned Public Authorities, he filed 2nd Appeal petition to the Commission on 24.6.2025 u/s 19 (3) of the RTI.

Hence, the present Appeal case.

Proceedings of the Hearing:

On the day of hearing on 22.7.2025, the Commission had directed the Public Authority (LR), Department to appear in person in the next hearing without fail.

On the day of hearing dated 5.8.2025, the Public Authority submitted that all the required information dated 29.7.2025 and 28.7.2025 had already been sent to the Appellant through WhatsApp he also added that a hard copy of the same was posted to the Appellant through GAD.

In the meantime, the Commission tried to contact the Appellant through the phone number enclosed in the RTI application. However, it has been found that the enclosed phone number is not used by the present Appellant and as such, the Commission could not collect any comments/ views from the Appellant during the hearing.

Accordingly, the Commission directs the SPIO of Land Resource Department to send/ deliver the hard copy of the information dated 29.7.2025 and 28.7.2025 to the address of the Appellant through registered or speed post without fail.

The Appellant is advised to provide proper contact number in future.

With this direction, the present Appeal case is closed.
