DECISION

Dated: - 29.7.2025

The Public Authority/ Executive Engineer, PHED, Tengnoupal, Manipur is absent. The Appellant is present through video conference.

Facts of the Case:

One Shri Momo Tantanga filed an RTI application dated 11.4.2025 to the SPIO/ EE, PHED, Tengnoupal Division, Manipur seeking information on three points u/s 6 (1) of the RTI Act. The pertinent information sought in the RTI queries are detailed below:

1. To provide the list of selected villages, with their work orders, sanction letters/orders, and completion reports for the construction of Public Toilets in Tengnoupal District, Manipur.
2. To provide the list of villages where the construction of Public Toilets has been completed and the bills have been fully disbursed, along with details of the bill disbursement for the respective works
3. Details of incomplete or pending bill yet to be disbursed for the construction of Public Toilets in Tengnoupal District, Manipur, along with relevant documents supporting the status of the pending or incomplete bill disbursements.

The concerned Public Authority/ EE, PHED, Tengnoupal failed to furnish the requested information thereby violating the prescribed timeline under the RTI law.

He moved First Appeal to the FAA, Department of Public Health Engineering, Government of Manipur on 14.5.2025 u/s 19 (1) of the RTI Act, 2005.

Having no relief, he filed Second Appeal petition dated 26.6.2025 to the Commission u/s 19 (3) of the said Act.

Hence, the present case.

During the hearing today, the Appellant submitted that he had already received all the required information from the concerned Public Authority and further expressed his contentment with the said information and lastly prayed the Commission for closing the present Appeal case.

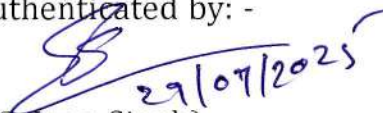
As the Appellant is satisfied with the information provided by the Public Authority, no further proceeding is called for.
