DECISION

The FAA and the SPIO are represented by Shri Y. Nongdrenkhomba, OSD (Legal). The Appellant Shri Momo Tantanga is present through Video Conference.

Brief Facts of the Case:

The Appellant filed the instant Second Appeal under Section 19(3) of the Right to Information Act, 2005 aggrieved by the non-furnishing of information by the SPIO and non-disposal of the First Appeal by the FAA. The Appellant had submitted an RTI application dated 14.08.2025 to the State Project Director, Sarva Shiksha Abhiyan (SSA), Manipur seeking the following information:

1. district-wise list of school drop-out students in the hill districts of Manipur for the last three years as per Proforma-A & B;
2. copy of the order/notification specifying the fixed rate structure of the scheme amount for drop-out students in both residential and non-residential categories;
3. number and detailed list of residential drop-out students from the hill districts who received the scheme amount during the last three years along with amounts disbursed;
4. number and detailed list of non-residential drop-out students from the hill districts who received the scheme amount during the last three years along with amounts disbursed;
5. copies of the sanction letters/orders issued by the Ministry or the State Government under the SSA for the drop-out scheme pertaining to both residential and non-residential students from the hill districts for the last three years; and
6. details of any projects undertaken for drop-out students in the hill districts during the last three years along with the list of beneficiaries.

The SPIO failed to furnish the requested information within the prescribed period of 30 days. Aggrieved thereby, the Appellant filed First Appeal dated 17.09.2025 (filed on 17-10-2025) before the FAA/Commissioner/Secretary, Education (S) Department, Government of Manipur. Even after the lapse of more than 60 days, no decision or response was communicated by the First Appellate

Authority. Hence, the Appellant approached this Commission through the present Second Appeal.

Summary of the Hearing:

Today, the Appellant appeared through video conference and submitted that he has received the complete information from the SPIO and is fully satisfied with the same. He, therefore, requested the Commission to close the present second appeal proceedings. The representative of the SPIO has no objection to the closure of the case.

Observation:

The Commission observes that the main grievance of the Appellant has been redressed as he has received the desired information and is satisfied with the same. Hence, no further adjudication is required.

Decision:

In view of the statement of the Appellant that he is satisfied with the information provided by the SPIO, the present Second Appeal is disposed of and closed. No further orders are required.
