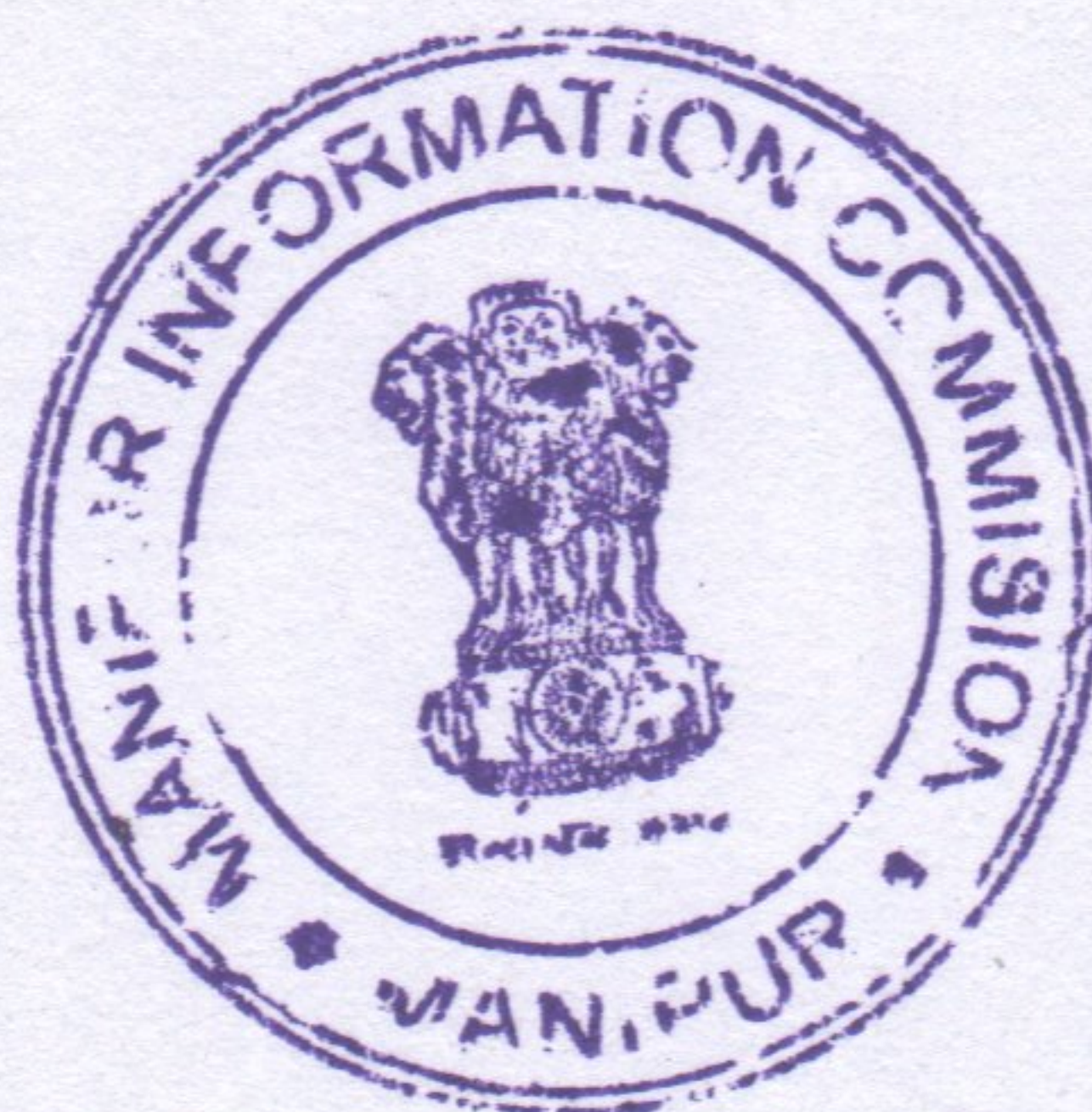
The SPIO/ Director (YAS), Manipur is represented by U. Augusta, Advocate through audio/ video conference. The Appellant is represented by Ms. Tejpriya, Advocate.

During the hearing the Ld. Counsel of the Public Authority, YAS placed a copy of the WP(C) No. 127 of 2024 (Ms. Pinky khuraijam -vs- The State of Manipur & Ors.) before the Commission. The present RTI Applicant challenge the whole DPC proceedings conducted by the YAS Department on 23.2.2020 for the recruitment of LDC in the YAS Department in the said Writ petition before the Hon'ble Manipur High Court.

In the meantime, the Ld. Counsel of the SPIO/ YAS reiterated that the present Writ petition is still pending in the Hon'ble High Court of Manipur. He added that the subject of request demanded by the Appellant may/ can interfere in the proceedings of the Hon'ble High Court of Manipur. He also stated that as the subject of request is under judicial consideration in another/ higher court, disclosure of the same may not be appropriate/ legally tenable in the present Appeal case.

After hearing from both the parties, the Commission is of the opinion that same cause of action shall not be demanded by the present Appellant in two different Courts.

However, a liberty is granted to the Appellant to file fresh RTI application to the concerned Authority after disposal of the present Writ petition by the Hon'ble High Court of Manipur. Accordingly, the present Appeal case is disposed of.
