The FAA and the SPIO are represented by Shri N. Shantajit Singh, LO and Shri L. Ibotombi, LO, respectively. The Appellant is also present.

Brief Facts of the Case:

The Appellant filed his RTI application on 16.10.2024, and sought certain information relating to Act and Rules of the Manipur Aided Colleges under the Directorate of University and Higher Education, Manipur. Getting no response from the SPIO, Directorate of University and Higher Education, he filed his First Appeal to the First Appellate Authority/ Commissioner (Hr. & Technical Education), Government of Manipur on 2.12.2024. The FAA disposed the First Appeal on 16.1.2025. However, being not satisfied with the decision of the FAA he filed the present Second Appeal to this Commission on 10.3.2025.

Summary of the Hearing and Decision:

The case was heard on 2.4.2025. During the hearing the representative of the Respondents submitted that the required information in respect of query No. 1 to 5 had been provided to the Appellant whereas the information in respect of query No. 6 was denied, as the required information is not specified as per Section 2 (f) of the RTI Act, 2005, and also, the type of information asked is not under the purview of the said Act.

The Appellant also submitted that he is satisfied with the information provided by the SPIO and agreed to close the Appeal proceeding.

Accordingly, the Appeal case is closed.
