DECISION

Shri K. Bimolchand Singh, Zonal Education Officer, Wangoi is present. The Appellant is also present.

Brief facts of the Case:

The Complainant filed his RTI application dated 27.12.2024 addressed to the SPIO/ Zonal Education Office, (ZEO), Wangoi, Imphal West, Manipur and sought the following information:

1. Parents' Name and Address: Please provide the names and addresses of the father and mother of the student.
2. Admission Details: Kindly provide information regarding the academic year in which the student was admitted to the school, documents used at the time of Admission, along with the class in which the student was enrolled at the time of admission.
3. Mid-Day Meal Photo: please provide a photograph of the student participating in the Mid-Day Meal program.
4. Class Teacher's Details: Kindly provide the name, contact information, and designation of the class teacher assigned to this student during the academic year.
5. Attendance Report of the Student: Please provide a detailed attendance report of the student for the entire academic year(s) in which the student has been enrolled in Phoubakchao Awang Junior High school.
6. Attendance Report of the Class Teacher: Please provide the attendance details of the class teacher during the student's academic year
7. School Inspection Report: Kindly provide any inspection report(s) related to the school for the relevant academic year, including the name(s) of the inspecting authority/official(s).
8. Head of the School's Information: Please provide the name and address of the Head of the School (Principal/Headmaster).

In response to the said RTI application dated 27.12.2024 and subsequent application dated 3.2.2025, the ZEO, Wangoi had furnished the required information/ reply vide letters dated 22.1.2025 and 11.2.2025. Being not satisfied with the information/ reply in respect of query No. 1, 2, 4, 5 & 6, the Complainant had filed the present Complaint application to this Commission on 19.2.2025 with a prayer for correction of wrong information (Data) entered by the Public Authority in UDISE with proper legal procedure as follows:

Summary of the Proceedings & Decision:

The case was heard on 24.3.2025, 17.4.2025, 5.5.2025 & 20.5.2025.

During the course of hearing the Appellant submitted that without consent of the guardian, his child was admitted/ enrolled in the Phoubakchao Awang Jr. High School by the Headmaster and the name of the student was also wrongly entered. He came to know about this fact only when his daughter was admitted at JJ school Montessori, Ghari Makha Leikai in Nursery for the academic session 2023-24 and at the time of registering of her name in the UDISE in October/November 2024. He also pressed for providing query wise information sought in his RTI application.

The SPIO has submitted his written statement dated 19.3.2025 and stated that the enrolment/admission of the student and its entry under UDISE PLUS is within the purview of the Head Master concerned. Accordingly, the information which were submitted by the Headmaster, Phoubakchao Awang Jr. High School has been provided to the Complainant vide letters dated 22-01-2025 and 11-02-2025.

With regard to the information relating to inspection report, the SPIO clarified that inspection of schools is made normally to monitor/ascertain as to whether teaching learning, proper implementation of certain schemes like PM-POSHAN etc., attendance of teachers and students are being made properly. And, such reports are maintained by the School concerned in a register.

The Headmaster, Phoubakchao Awang Jr. High School vide his letter dated 07-02-2025 had submitted the information/reply to the ZEO, Wangoi. He also clarified that the particulars of the student was collected from the nearest Anganwadi Centre which is situated near the school premises as a part of the admission drive to boost in the school enrolment as it is assumed that every local student has to admit in the nearest primary school after Anganwadi period and his name along with some other students were included for registering under UDISE PEN No. Further, he submitted that he came to know that the particulars of the student was not correct and also as the said student did not attend the school, his admission was already cancelled and the present status of PEN No. of the student was in the drop box.

During the course of hearing on 24-03-2025 and 17-04-2025, the representative of the SPIO submitted that the lone teacher of Phoubakchao Awang Jr. High School Shri Angom Tiken Singh, Head Master also retired from service recently. The school has no teacher as of now.

Shri Angom Tiken Singh, Headmaster (Rtd.), Poubakchao Awang Junior High School has submitted and clarified that next to his School there is an Anganwadi Centre and the detail of the 4 (four) students were collected from the said Anganwadi Centre for enrolment in their School. He also submitted that this was the first time of such collection of details of the students. However, due to the present crisis which had erupted from May 2023 onwards no students attended the School and no mid-day meals were also provided. The student namely, Angom Luchingba was also admitted in Class I as his details were obtained from the Anganwadi worker of the said Anganwadi Centre in March, 2023 without the student's physical presence and relevant documents.

Considering the nature of the case, the Commission advised the Public Authority represented by the ZEO, Wangoi to complete the process of deleting/ rectifying the mistake that has occurred in the UDISE data entry in respect of the present Complainant's child vide decision dated 17-04-2025.

The ZEO, Wangoi has submitted a compliance report today regarding rectification of the mistake that has occurred in the UDISE data entry in respect of the present Complainant's child and a copy of the same was also furnished to the Complainant.

Now, the Commission finds that the mistake which had occurred in the UDISE data entry in respect of the present Complainant's child is found corrected as prayed by the Complainant in his Complaint application dated 19.2.2025. And, hence no further proceeding in the present Complaint case is called for.

With the above observation the Complaint case is closed.
